

# Submit your income tax return online at [www.skatteverket.se](http://www.skatteverket.se), by app, text message or phone



You can then get your income tax refund before Midsummer.

## Submit your income tax return simply and securely

**It's simple.** Before you start, check that all filled amounts on your income tax return are correct. The codes you need in order to approve the information appear at the top of the specification you received along with your income tax return form.

**It's secure.** You use your personal security codes. You will also find out right away whether your income tax return was received by the Swedish Tax Agency.

### At [www.skatteverket.se](http://www.skatteverket.se) With personal security codes

You can submit your income tax return online at [www.skatteverket.se](http://www.skatteverket.se) using your personal security codes if you want to make deductions for travel to and from work or only need to approve the information on your return.

#### With e-ID

With e-ID you do not need the personal security code. You can also do much more in your tax return:

- Change or add information
- Fill out and submit supplement K2 if you are voluntarily reversing a deferment or have a preliminary deferment that is to be final
- Fill out and submit supplement K4 if you have sold shares
- Fill out and submit supplement K5 if you have sold a single-family dwelling
- Fill out and submit supplement K6 if you have sold an owner-occupied flat
- Fill out and submit trader supplements NE, NEA, N8, N3A, T1 and T2 as well as the supplement K10 and VAT supplement
- Report earnings from renting out residential property.

#### What to do:

Go to [www.skatteverket.se/deklaration2014](http://www.skatteverket.se/deklaration2014). There, you will find out how to proceed.

### Using our app on your smartphone

You can submit your income tax return via your smartphone by using your personal security codes or "Mobilt BankID".

Do be able to submit your income tax return with "Mobilt BankID" you need to:

1. contact your bank to get "Mobilt BankID"
2. download the app "BankID".

## By sending a text message to 71144

### What to do:

1. Create a new text message.
2. Enter your Swedish personal identification number (10 digits).
3. Type space after your Swedish personal identification number and then enter your signature code (8 digits).

#### Exempel:

5803012805 99999999

4. Send the text message to 71144. You will receive a text message back within 10 minutes saying, "Din deklaration har nu kommit in till Skatteverket" (Your income tax return has now been submitted to the Swedish Tax Agency).

## By phone – dial 020-567 100

When you call a recorded voice (in Swedish or English) will tell you what to keep in mind when submitting your income tax return by phone. You can stop the message whenever you like by pressing star (\*). The message will be re-read from the beginning.

### What to do:

- If you want to start submitting your income tax return, **press 1.**
- If you would like more information, **press 2.**
- To end the call, **press 9.**

### After pressing 1, you will hear the following:

- You have chosen to submit your income tax return.
- Enter your Swedish personal identification number (10 digits).
- Then press hash (#).
- Enter your identification code (8 digits).
- Then press hash (#).
- If all the amounts are correct, you can now submit your income tax return by entering your signature code.
- Enter your signature code (8 digits).
- Then press hash (#).
- Your income tax return has now been submitted to the Swedish Tax Agency – thank you for using our self-service telephone.

If you aren't sure whether your income tax return has been received, you may call us again. Once you have entered your personal identity number and codes, you will hear this message. "You have already submitted your income tax return".

## Income tax refund before Midsummer

If you are employed, draw a pension, a businessman or shareholder in closely held companies, sales firms or limited partnership you can get your income tax refund as early as June. But to be sure of this you must (by 5 May, 2014 at the latest)

- Submit your income tax return through [www.skatteverket.se](http://www.skatteverket.se), app or text message, or by calling
- give us your bank account number, unless you have already done so.
